Treat : Summertime Jigglers (for dogs)

4 Envelopes Unflavored Gelatin

1 Cup Carrot

3 Cups Apple Juice

1Tbs. Honey

In a large bowl, sprinkle gelatin over carrot juice and let stand 2 minutes.

Meanwhile, heat apple juice until hot but not boiling. Stir into juice mixture. Stir for

2-3 minutes. Add honey and stir again. Pour into a large flat pan (9X13 works well).

Refrigerate until firm. Cut into squares and serve outside. Treats will stain, but taste so cool and good!
