

**POLITICAL SAVVY 101**

I met with my Contra Costa County Supervisor Mark DeSalnier and his Chief of Staff Gregory Bedard on November 14. What follows is a shorter summary of what I discussed with him. I also left a copy of my complete list of concerns to be copied and distributed to the rest of the supervisors.

**ORDINANCE NO. 2005-24**  
**Article 416-12.4 Dangerous Animals**

**These are my concerns with the ordinance. I have noted the ten I have on the copy of the ordinance and have also identified and discussed them by identifying page and section numbers on these pages.**

*(Concern # 1)*

**Section 416-12.402 Potentially dangerous animal**

\_\_\_\_\_“Potentially” is a very general word and could be interpreted differently by different people. “Potential” could develop into a breed specific issue with one incident of a dog of a particular breed labeling the entire breed as “potentially dangerous” and subject to enforcement under this ordinance. A more precise word would be “demonstrated to be dangerous.”

*(Concern # 2)*

( d). Any animal, when unprovoked, has engaged in **any behavior** that constitutes a physical threat of bodily harm to a person or domestic animal or **poses an immediate threat to public safety** (**Ords. 2005-24 Para2.87-74**)

\_\_\_\_\_“Any behavior” again is very vague and could have as many different interpretations as there are people witnessing the particular dog behavior. An overly friendly dog attempting to greet a fearful person may be interpreted as an aggressive act. The actions of the owner giving a leash correction to prevent the Friendly dog from contacting the person may well be interpreted as the handler preventing the dog’s aggressive behavior. In the event that that person files a complaint, if there are no witnesses to the incident, it is a question of whose word is believed. Even trained and obedient dogs have periods of regression and can make an error in judgment. This does not constitute an aggressive act, only a poor decision on the dog’s part.

**Section 416-12.406 Hearing Procedures**

*(Concern # 4)* (d) The animal services director will **consider** the following factors in determining whether an animal is potentially dangerous or dangerous.

\_\_\_\_\_I think here something more specific should be stated that would comfort the owner whose dog on a single occasion commits what may be interpreted as an aggressive act. Dogs as a species greet in different ways which may be interpreted as aggressive. They may not be aggressive acts but simply dog greetings. People who are fearful of dogs due to a previous negative experience or who do not understand dogs may misinterpret these greetings. Anyone visiting a dog park has witnessed this.

**Section 416-12.422 Permit Conditions**

*(Concern # 5)* (f) Permittees shall display on the property where the animal is kept a sign containing a warning that there is a potentially dangerous dog on the premises.... **The sign must be located where it will be visible to the general public.**

\_\_\_\_\_Anyone who has had a number of dogs of a particular breed knows that while there are general specific breed characteristics, no two dogs are exactly alike. They are genetically and temperamentally separate entities. My first Doberman was a poor specimen of the breed temperamentally. Every other Doberman I have owned since then has been totally different in temperament. In addition, each has had a different personality. How is it fair to post a sign condemning an entire household of dogs, making it unclear to the neighborhood *which* dog contained therein is considered aggressive and dangerous? Neighbors will not stop to consider which dog; they will simply be wary of all the dogs and of that person residing in the posted house. In posting this sign, you condemn all the dogs that have not been labeled as “dangerous” except by association, How unfair and how un-American! Questionable too is how this will be interpreted by the insurance companies.

*Concern #7)*

(k) The animal services director must be allowed **at any reasonable time** to inspect the animal and the place where the animal is located.

\_\_\_\_\_I would further add “by appointment.” I do not consider a Gestapo-like sudden and unexpected “visit” by the animal services director to be “reasonable.”

(Concern # 8)

(1)The potentially dangerous animal must **complete** an obedience course **approved by the animal services director...**

\_\_\_\_\_In my contacts with the animal services department personnel, I have not been convinced they are competent or have the time and resources to judge the type of obedience training such a “potentially dangerous” dog requires. I know from experience that many clubs do not have the capacity to deal with very disruptive dogs in a class situation. A better judge of the dog’s ability to be trained would be an obedience instructor or a behavioral specialist. Nor do I feel just “completion” is sufficient. It would be more correct to state the dog must not only complete a class but his behavior in the presence of other dogs and people must be approved by the trainer and the animal services director. Most obedience clubs offer a Canine Good Citizen Test which offers one way of judging the dog’s behavior while under the owner’s control away from the home. (See enclosed material.)

**Section 416-12.430 Exception**

(Concern # 9)

**Nothing in this chapter shall limit the right of any person or officer to take any proceedings against a potentially dangerous or dangerous animal or its owner or keeper that are otherwise permitted or provided by law.** (Ord. 2005-24 Para. 2, 80-97)

\_\_\_\_\_Again this is too general and leaves the interpretation wide open to abuse and condemnation of an innocent animal. It has dangerous potential for hysterical reactions by “any person.” In our litigious society, this is an open invitation to law suits and actions by Insurance companies.

**Conclusion:**

While this ordinance attempts to send a strong message to those people who abuse and misuse dogs, it has what I consider dangerously loose language open to misinterpretation by well meaning and not so well meaning folks. I think, however, while it may serve to punish those who use animals to deliberately inflict harm, it also will harm those law abiding people who own dogs, love and nurture them, and like the members of my dog training club, take the time to train them. We are people from all walks of life who spend our lives devoted to our dogs. We raise them carefully, take them to training classes and show them in American Kennel Club events in obedience trials, agility trials, and rally trials. Those of us with larger working breeds such as Dobermans, Rottweilers, Shepherds, etc, feel we are in danger of being labeled as having “potentially dangerous dogs” because of the size and history of those breeds. Ironically, we are the people who are aware of the need to train and socialize

these dogs. We stand in danger, however, of being labeled by One incident involving our breed and a knee jerk reaction to the situation as has already happened in the bay area. You as a Rottweiler owner can well appreciate our concern. As you stated to the San Francisco Chronicle On October 26, 2005,

“From my perspective, [the ordinance] is directed toward the humans, in this case felons. This isn’t about the dogs.”

Unfortunately, in the various instances I have noted in this letter, it could very well become about the **dogs**. I am grateful for having this opportunity to speak with you both for myself and on behalf of my club, The Mt. Diablo Dog Training Club of Walnut Creek. If you will read the information I have enclosed about me and about my club, you will see we have the dogs’ well being at heart. We believe in and promote responsible dog ownership. ### **Letter from Mark DeSaulnier in Response to his meeting with Irene Quesnoy**

Dear Ms. Quesnoy,  
Thank you very much for stopping by my office to meet with me earlier this week about the Dangerous Animal Ordinance. I greatly appreciate the research you conducted and the thoughtful analysis of the ordinance's language that you provided for my review.

As you probably know, the Board took action on November 15 and unanimously passed the dangerous animal legislation. However, as part of the Board's action, we required the Department of Animal Services to continue to take public comment and to both relay those concerns to the Board along with Responses as to how those concerns will be met by that department when enforcing the new ordinance.

I feel confident that as responsible Doberman and Rottweiler owners, respectively, we will be well served by the new legislation and that the Department of Animal Services will use proper judgment in its enforcement. This ordinance will focus on the ownership of dogs by convicted felons and on those individuals who are raising aggressive dogs that intimidate neighbors and cause the public's safety to be in jeopardy.

Again, thank you for taking the time to meet with me and share your concerns. I appreciate your civic participation very much.


