OFFICIAL NOTICE - CHANGE OF JUDGE FOR MORNING OBEDIENCE TRIAL (Event #2021132210)

In order to balance the judging assignments for the smooth running of the Trials and with AKC Approval, the Obedience Novice A Class in the Morning Trial will be judged by Mrs. Laura Delfino, replacing Mr. Alvin Eng. Any exhibitor affected by this change is entitled to a full refund of the class entry fee. Submit request for refund in writing to the Trial Secretary anytime up until 30 minutes prior to the start of judging of the Morning Trial.

Dogs may arrive any time prior to scheduled time of judging. Dogs not required for further judging may be excused. Judges are not required to wait for any dog. They will adhere as closely as possible to the judging schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when it is to be judged. All dogs present must be held on leash or confined to their crates except when being judged. No practicing is allowed in any ring at any time. Judges may take breaks at their discretion.

Trial Information

- CLASS TRANSFERS (Move-ups) are allowed for dogs completing a title after close of entries. The request must be made IN WRITING to the Trial Secretary at least 30 minutes prior to judging. Transfer requests will also be accepted prior to the day of the event.
- BITCHES IN SEASON are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. A processing fee of \$10.00 per entry will be retained. A signed veterinarian's letter stating the bitch is in season may be provided as documentation with the request or within one week of the trial at the latest to receive a refund.

Directions to Trial Site

FROM HIGHWAY 1 North or South. Exit at the Airport Blvd exit. Airport turns into Holohan, turn left on E. Lake Ave. St. Francis High School is .36 miles on the right just after passing Lakeview Middle School. Paved parking is on your right as you enter.

FROM GILROY, HIGHWAY 101 HEADING NORTH (from Salinas, towards San Jose). Take Monterey Road from the south, turn left onto First which is Hwy 152. Once on Highway 152 the road continues over mountain. It becomes East Lake Ave. After passing the County Fairgrounds on your right, St. Francis High School is about a quarter mile on the left, across from the Lady Help of Christians Church.

FROM GILROY, HIGHWAY 101 HEADING SOUTH (from San Jose, towards Salinas). Take Exit 357 from the north via Leavsley Rd (west), turn left onto Monterey Rd. Turn Right onto First Street which is Hwy 152. Once on Highway 152 the road continues over mountain. It becomes East Lake Ave. After passing the County Fairgrounds on your right, St. Francis High School is about a quarter mile on the left, across from the Lady Help of Christians Church.

NOTE: This is the GILROY GARLIC FESTIVAL weekend! The Gilroy route is not recommended after 8:00 AM due to extensive traffic delays.

Please follow all parking instructions and regulations at St. Francis High School. No overnight RV or tent camping is permitted at the trial site.

A Warm-Up Ring will be available for exhibitors, starting at 7:30 AM. There is a five minute time limit per dog. Sign-ups will be on a first come, first served basis. Food and toys are allowed but please do not leave food on the ground. NO CORRECTIONS OR INTENSIVE TRAINING are allowed in the warm-up ring or on the trial grounds. The warm-up ring will be open until the end of the trials.

NO FOOD will be available on the grounds. Exhibitors, please bring your own lunch, beverages, and snacks.

Driving Directions to Veterinarian: Driving Directions to Veterinarian: Leaving the show site, turn left to go southwest on E Lake Ave/CA-152 toward town. Turn right onto Holohan Rd. Holohan Rd becomes Airport Blvd. Continue on Airport Blvd past Watsonville Hospital. Take the CA-1 ramp toward Santa Cruz (right turn then an almost immediate left onto freeway). Merge onto Hwy 1 North.

Take the 41st Avenue exit, EXIT 438 (approx 10 miles from entering Hwy 1). Turn right onto 41st Avenue. At the end of 41st, turn left onto Soquel Drive. Pacific Veterinary hospital is approx a half mile on your right (three stop lights prior to hospital).

Driving Directions: From show site, go southwest on E Lake Ave/CA-152 toward town. Turn right onto Holohan Rd. Holohan Rd becomes Airport Blvd. Continue on Airport Blvd to Watsonville Hospital. Turn left onto Neilson St which is 0.2 miles past Hangar Way. Turn right into the first driveway into the hospital grounds. Follow the signs to Emergency at back side of Watsonville Community Hospital, 75 Neilson St, Watsonville, CA.

Updated COVID-19 Information and Instructions

These protocols have been updated since publishing the premium list. Based on COVID-19 conditions and County regulations on the day of the trials, further changes may be required. Any new guidelines will be posted at the trial site.

- 1. These Trials will be held if allowed under emergency regulations in effect at the time of the Trial. The Club, officials and participants are required to follow state, local, and facility guidelines applying to St Francis High School, the City of Watsonville, Santa Cruz County, and the State of California. In the case the trials are cancelled, a FULL REFUND of exhibitor entry fees will be made.
- 2. **ANY EXHIBITOR FEELING ILL OR HAVING SYMPTOMS MUST STAY HOME!!!** Contact the Trial Secretary at (510) 915-0597 or DLBest7@earthlink.net to cancel and receive a refund.
- 3. Exhibitors: Please bring your own protective gloves and face mask. Club will provide hand sanitizer. All exhibitors should practice "Social Distancing", keeping at least 6 feet between other people. See below for updated face mask policy.
- 4. Please park your vehicle with increased distance between vehicles.
- 5. Crating setups should be placed at least six feet apart, except for "family" groups of exhibitors and dogs from the same household.
- 6. Avoid shaking hands or hugging. Avoid touching dogs that are not your responsibility.
- 7. Avoid using common pens / pencils. Bring your own pen for self check-in at ringside.
- 8. Bring your own meals and snacks. The club regrets that it will not provide morning food hospitality for exhibitors. No potlucks.
- 9. Please limit the people attending to as few as necessary. We ask that you leave the grounds when finished exhibiting, except if you are entered in both trials, or may be eligible for high scoring awards.
- 10. **UPDATE:** MASKS AND SOCIAL DISTANCING. Current guidelines direct unvaccinated persons to wear a mask unless they are in their own personal crating area or vehicle. Vaccinated individuals are not required to wear a mask.
- 11. <u>UPDATE:</u> Judges may set additional requirements for exhibitors and stewards inside their rings, which may include the wearing of face masks.
