Distemper continues spread through County

Animal shelter encourages vaccinations for pets

rstuart@santacruzsentinel.com SANTACRUZ » Distemper has continued to spread through Santa Cruz since its outbreak earlier

this year. The Santa Cruz County An-imal Shelter identified an outbreak of distemper on the westside of Santa Cruz in February. The outbreak has now spread to a Seabright neighborhood, according to Program Development Manager Ericka Smart.

"There's definitely a concern. Right now, we're unsure of how far exactly it will go," she said. With it spreading from the westside to Seabright in just a few months, it's obviously impacting the community."

Despite the spread of the disease primarily through covotes and racoons, residents should not be concerned if they spot a coyote or racoon. If one of those animals is spotted, observe its behavior. A wild animal is worth report-

ing intoxicated, according to hold pets. Smart. It will move slowly and The animal shelter continues to may stare at a person but not act as if it sees the person. Animals afflicted by distemper will exhibit caked up eyes and will appear disoriented.

"If it's acting abnormally, they can report it," Smart said. "If they see a racoon strolling through their yard late at night, they don't

need to report that." Distemper can spread to a large number of animals and has no known cure. However, the spread is no cause to panic. There are methods for preventing ing to animal control of it is act- the spread of the disease to house-

urge pet owners to get their pets vaccinated, Distemper and Parvo inoculations are \$20 through the animal shelter. The shelter also provides the rabies vaccine for both cats and dogs. The vaccine is \$10 for cats and \$10 for dogs with a license renewal.

License renewals for dogs are \$29 if they are spayed or neutered and \$100 if they are unaltered. The rabies vaccine is free for firsttime licensed dogs, according to a press release from the county. The animal shelter is also offering to microchip cats and dogs for \$15.

"We don't see domestic animals getting (distemper). But the only way to protect against it is by get ting your pets vaccinated," Smart said. "It's in the best interest of people's pets to have them vaccinated, especially with this type of outbreak going on."

While vaccination is the best way to protect pets from the disease, there are other efforts that lower an animal's chance of exposure. The shelter suggests pet owners refresh and wash outdoor water bowls to prevent communal spread. Affected coyotes and racoons can leave the disease behind when using these bowls.
