MEMBER BRAGS



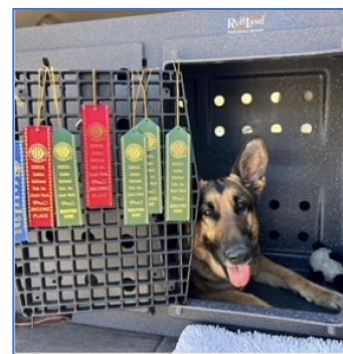
